TRUST DEED

This DEED OF TRUST is made on this, the 6th day of March, 2006 at Bangalore by Mrs Sanghamitra Iyengar, aged about 54 years, at present residing at 5, Sakshi Apartments, III Cross, HMT Layout, R T Nagar, Bangalore 560 018 [hereinafter referred to as "the Settlor" which expression shall, unless repugnant to the context or meaning thereof, be deemed to include her successors, executors and administrators]

WHEREAS, the Settlor is possessed of and otherwise well and sufficiently entitled to a sum of Rs. 1000/- (Rupees one thousand only) and is desirous of establishing a public charitable TRUST to contribute to improving the quality of life of vulnerable people especially in the area of health and in areas impacting health such as education, gender equality, livelihoods etc.

AND WHEREAS, the Settlor has named five TRUSTEES including herself, whose names are given in this TRUST DEED, and who have agreed to become the FOUNDER TRUSTEES of this TRUST.

NOW THIS DEED OF TRUST WITNESSESS that, for the purpose of effecting the said desire, the Settlor has irrevocably transferred the said sum of Rs. 1000/- (Rupees One Thousand Only) to the TRUSTEES (the transfer whereof the TRUSTEES do and each of them doth hereby admit and acknowledge) being subject to the uses and trusts hereinafter mentioned.

2. PREAMBLE

HIV/AIDS presents major challenges to human development with implications far beyond the health sector.


The prevalence of HIV/AIDS in all parts of India highlights the spread from urban to rural areas and from high risk to the general population. Migration of labour, low awareness, gender disparities, poverty and livelihoods issues, lack of health facilities, are some of the factors attributed to the spread of HIV/AIDS.


HIV/AIDS threatens all segments of society. A social response of blame, discrimination and stigmatization of HIV positive people can lead to further exclusion of people who are already marginalised. There is an urgent need for all those concerned with this issue to immediately proactively and with great sensitivity, address this challenge.

3. OBJECTS:

The TRUST shall work to improve the quality of life of vulnerable people in defined periods of times especially in the area of health and development including all areas impacting health such as education, gender equality, livelihoods etc in order :

- 3.1 To halt and reverse the spread of HIV infection;
- 3.2 To reduce the impact of HIV and AIDS on populations at risk of and vulnerable to HIV;
- 3.3 To reduce the impact of HIV on individuals, families and communities living with and affected by HIV and AIDS, through any social and developmental intervention that may be appropriate;
- 3.4 To improve the reproductive and sexual health of men and women in the community with special attention to youth and adolescents;
- 3.5 To promote the social acceptability of sexual minorities, and restore/safeguard their basic human rights;
- 3.6 To restore and safeguard the basic human rights of individuals marginalised/stigmatised by health or social conditions, especially those vulnerable to HIV and AIDS;
- 3.7 To work beyond HIV, in health and development of vulnerable populations;
- 3.8 To ensure the participation and involvement of the populations that the TRUST works with;
- 3.9 To support individuals, organisations and communities regionally, nationally and internationally through training and capacity building activities towards the above objectives;
- 3.10 To collaborate with local, state, national and international bodies towards the above objectives;
- 3.11 To be involved in policy formulation on all related issues at local, regional, national and international levels;
- 3.12 To undertake research related to these areas of work;
- 3.13 To bring together all human, financial and material resources of whatsoever kind, to give or procure such advice, to take such initiatives, to provide such services and to proffer such assistance and guidance as the trustees think fit.
- 3.14 To undertake all activities that are conducive to the achievement of the above objectives.
