


a) That the trustees shall have the following powers:

- i. to manage all the assets and/or properties of the trust;
- ii. to appoint employees and to settle the terms of their service, remuneration and termination;
- iii. to look into the management of the trust;
- iv. to invest the funds of the trust and to utilize the income generated from those investments for the purpose of carrying out the objects of the Trust;
- v. to sell, alter, vary, transpose or otherwise dispose or alienate the trust properties or any investment representing the same for consideration and to reinvest the same;
- vi. to pledge or mortgage the trust properties for raising loans;
- vii. to open the bank accounts in the name and on behalf of the trust and to operate the same;
- viii. To enter into a contracts, vary or rescind them;
- ix. To pay all charges, impositions and other outgoings payable in respect of the trust properties and also to pay all cost of the incidental to the administration and management of the trust properties;
- x. To file suit on behalf of the trust and to refer to arbitration all actions proceedings and disputes touching the trust properties and to compromise and compound the suits filed;
- xi. To accept any gift, donation or contribution in cash or in kind from anyone for the objects of the trust;
- xii. To seek legal opinion of lawyers and/or Chartered Accountants as and when required;
- xiii. To nominate their representatives for any of the aforesaid purposes.

- xv. To incur all necessary expenses connected with the Trust, its institutions and projects;
- xvi. To do all other acts and things which may be necessary from time to time to fulfill the objects of this trust in the interest of the Trust;
- xvii. The Trustees shall have absolute powers to sell movables and immovable properties for the better utilization and use the proceeds thereof for the purpose of fulfilling the object of the Trust
- xviii. To borrow the funds with or without securities to generate the funds for the capital projects of the Trust
- xix. The Trustees shall have absolute powers to amend the clauses of the Trust subject to the conditions laid down in this deed
- xx. To form a sub committees and to frame rules for the effective management of the Trust
- xxi. To appear and act before Courts, Tribunals, Government, Municipal, Tax and other Public or local authorities

b) In case of any difference between the trustees, the opinion of the majority shall prevail.

c) Every trustee will be at liberty to nominate or appoint attorneys or agents and to delegate all or any of the duties and powers vested in him to such attorney or agent, and to remove such attorney or agent and reappoint other or others in his place.

d) No trustee shall be responsible or liable for any loss or any act of omission or commission by his constituted attorney or agent or employees or other trustees unless occasioned by his wilful neglect or default.

Provided that the Trustees may employ any of the Trustees being engaged in any profession or business or in a firm of which he shall be a member to do any act or transact any business (Whether any business (Whether or not an act or business which only a person engaged in that profession or business can do) and may pay such charges for the act or business done by him or his firm as aforesaid as he or they might recover if Trustees whose firm may be so employed was not a Trustee.

#### XIV DECISION OF THE MANAGING TRUSTEES:

b.The accounts of every year shall be audited by a Chartered Accountant or a firm of Chartered Accountants who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.
