

**1. Name**

**2. Objects of the trust**

- i) To establish and run a Vocational Centre for Differently Abled Adolescent Children at Pestalozzi Childrens' Village, Magadi Road, Bangalore .
- ii) Improve the educational, health and nutritional status of poor and needy and differently abled and adolescent children, and children at the Orphanages and school in Pestalozzi Childrens' village and other places.
- iii) To fund money for the improvement of education and health of differently abled adolescent children who cannot afford it due to sheer poverty.
- iv) To establish and run sports / recreation centre, Science Activity Centre, Exploratory Centre, Horticulture / Gardening Centre, Cultural Centre for performing and visual arts, Education and Leadership Training Centre, job oriented / vocational training centre, medical centre of Indian forms of treatment for the benefit of poor and needy children of all ages and differently abled children.
- v) To accept hold or administer any gifts, grants, donations or contribution in kind or money and to make undertake and execute any trust which may be deemed conducive to any of the objects of the trust.
- vi) To take such steps by personal or written appeals or by advertisement or otherwise as may be deemed expedient for the purpose of publishing the functions and activities of the trust in the shape of donations, subscriptions or otherwise.

- vii) To accept grants in aid from foreign funding agencies, central and state governments, and any other bodies which support such development programs.
- viii) To borrow money or receive money or deposit upon such terms funds and assets of the trust as the board to trustees shall deem necessary or expedient for fulfilling the objects of the trust.
- ix) To act, associate, participate in conjunction, co operation and co ordination with other Institutions, Societies and Trusts having similar objectives of education, health and poverty alleviation to the poor and needy, recognized by tax and other regulatory authorities in general.
- x) Generally to do all such other things as deemed incidental or conducive to the attainment of all or any of the above objects, including securing / providing infrastructure and logistical necessities required for that purpose.
- xi) The benefits of the trust shall be available to public at large without distinction of caste, creed, color, religion or gender.

## 2. Property vested in the trustees

The founders doth hereby transfer a sum of Rs. 50,000/- (Rupees Fifty thousand only) in favour of the trustees and unto the trustees thereof. The trustees shall hold the said fund and other properties that may be endowed or conferred for the said trust for the use and benefit of the trust. The trustees shall out of the income realized from the properties endowments and such other endowments or donations which they may get, pay all taxes and rates and all expenditure connected with the trust.



(b) The Board of Trustees of the Trust will ordinarily consist of not less than 5 [Five] members and ordinarily not more than 18 [Eighteen] members. The trustees may co-opt to the board of trustees, if necessary, to make the total number to eighteen.

(c) The trustees shall act as trustees for life except in the case resignation and if the majority of the total strength of board of trustees find that any of the trustee is guilty of misfeasance, nonfeasance or omission or dereliction of duty, he may be removed from the board.

(d) Any vacancy that may arise among the trustees including that of the office bearers due to the reason of ill health, resignation, removal or otherwise by any law in force shall be filled up by the simple majority of the decision of trustees.

(e) The Trust may have an Advisory Board to which eminent people from different walks of life may be invited. The Advisory Board will ordinarily consist of not less than 5 [five] and not more than 15 [fifteen] members. The term of the Advisory Board will be one year, subject to extension for such further period as the trustees may desire.

(f) The President, Secretary and President – elect and one of the senior member of Rotary Bangalore West may be invited on to the advisory board at the commencement of every year.

#### 4. Funds of the trust

- The funds of trust shall be by subscription, donation, interest on investment, rent and any other source of income recognized by law & the trust.
- The funds & the income of the trust shall be solely utilized for the achievement of its objectives & no portion of it shall be utilized for payment of the trustees by way of profit, interest, dividends, etc.
- The trustees may open and operate current or deposit or other accounts with any scheduled bank or other banks and by resolution authorize any one or more of the trustees either singly or jointly or severally to operate on such accounts.
- There shall be maintained all accounts of the trust regularly. The accounts shall be duly audited by the chartered accountant. Every year, the accounts shall be closed by 31<sup>st</sup> March, and required statutory compliances be conducted.
- Proper books of accounts shall be maintained by the trust and shall be audited by a chartered accountant

The office bearers shall hold office for a period of 3 [Three] years or until the new office bearers are elected. The retiring office bearers may be elected again by mutual agreement of the trustees.

**6. Meeting of the Trust / Board**

The Chairman shall act as the chairman of any meetings. In the absence of the Chairman at any meeting, the trustees present may elect one among themselves as chairman of the meeting. The Board of Trustees shall meet at regular intervals such that there shall be one meeting every quarter of the year. In any resolution to be passed regarding the administration of the trust, the opinion of the majority shall prevail. It shall be competent however for the trustees to decide matters by circulation.

**7. Powers and duties of the trustees.**

- (a) The trust may receive donations of money and/or properties when received shall be at the absolute disposal of the trust.
- (b) The trustees shall invest the properties and moneys of the trust in such manner only as prescribed under sec.11 (5) of the income-tax act, 1961.
- (c) In case there being equality of votes, the chairman of the meeting has casting vote for the purpose of the deciding the issue.
- (d) In the event of dissolution or winding up of the trust the assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees or the board of trustees but the same shall be transferred to another charitable trust whose objects are similar to those of this trusts and which enjoys recognition u/s.80G of the income-tax act 1961 as amended from time to time.
- (e) No amendments to the trust deed shall be made which may prove to be repugnant to the provisions of the sections 2(15),11,12,13, & 80G of the income-tax act 1961, as amended from time to time. **FURTHER NO AMENDMENT SHALL BE CARRIED OUT WITHOUT THE PRIOR APPROVAL OF THE COMMISSIONER OF INCOME-TAX.**
- (f) The board may by resolution extend the activities of the trust or undertake any activity in furtherance of the main objects of the trust.
- (g) To board may do such other lawful things as are incidental in carrying out the administration and management of the trust.
- (h) The trustees shall maintain the minutes book in which the proceedings of all meetings of the trustees shall be recorded by the trustees and the same shall be signed by the chairman of the meeting.

- (i) The trustees may frame rules and regulations as to the duties and responsibilities of each Trustees to appoint sub-committees, mode of conducting any other matters connected with the administration of the trust and its management.
- (j) The post of all trustees shall be honorary. However, every trustee shall be entitled to be reimbursed the amount he might expend for the purpose of the trust.
- (k) Any member of the trust including the office bearers shall be suspended or removed if he is declared an insolvent, has been convicted of an offence involving moral turpitude, and in the opinion of the majority office bearers that the conduct of any member is not conducive, or is detrimental to the interest of the trust.

**8. Custody of documents.**


The Chairman or his nominee or any other trustee if so authorized by the board of trustees shall have the custody of all the documents, deeds of title relating to the trust properties and investment, and the books of account and another records relating to the trust and shall be responsible for the preservation of the same.

**9. Irrevocability**

It is declared that the trust is irrevocable. If the trust fails for any reason, in the opinion of the trustees, the net assets of the trust shall be handed over to any other trust having the same objects and which is recognized under section 80G of the Income Tax Act, 1961, as decided by the majority of the trustees.
