REGISTRATION UNDER SECTION 12AA(1)(b)(i) OF THE INCOME TAX ACT, 1961

- 2. The name of the Trust has been entered at <u>S.No. K-761</u> in the Register of application u/s. 12A(a) of the Income Tax Act, 1961 maintained in this office.
- 3. No change in the Memorandum of Association of the Trust shall be effected without due procedure of law and its intimation shall be given immediately to this office.
- 4. The registration u/s. 12AA of the I.T. Act, 1961 does not automatically exempt the income of the Trust. The question of taxability of the income of the Trust shall be examined and decided upon the Assessing Officer (A.O.) based on activities, compliance with various statutory and other requirements, etc., which the trust is obliged to abide by irrespective of Registration granted by this order.
- 5. The registration u/s. 12AA of the I.T. Act, 1961 does not automatically confer any right of deduction u/s. 80G to the donors.
- 6. This certificate cannot be used as a basis for claiming non deduction of tax at source in respect of investments, etc., relating to the Trust.
- 7. The Trust shall furnish a return of income every year within the time limit prescribed under Act.
