ORDER U/S-12AA OF THE INCOME-TAX ACT, 1961

1.0. M/s. Dantan Manav Kalyan Kendra [Hereinafter, shall be referred to as "The Institution"], was registered as a Society on 02.07.2004. The Institution has filed an application seeking registration u/s.12AA of the Act; and benefit u/s.80G of the Act.
