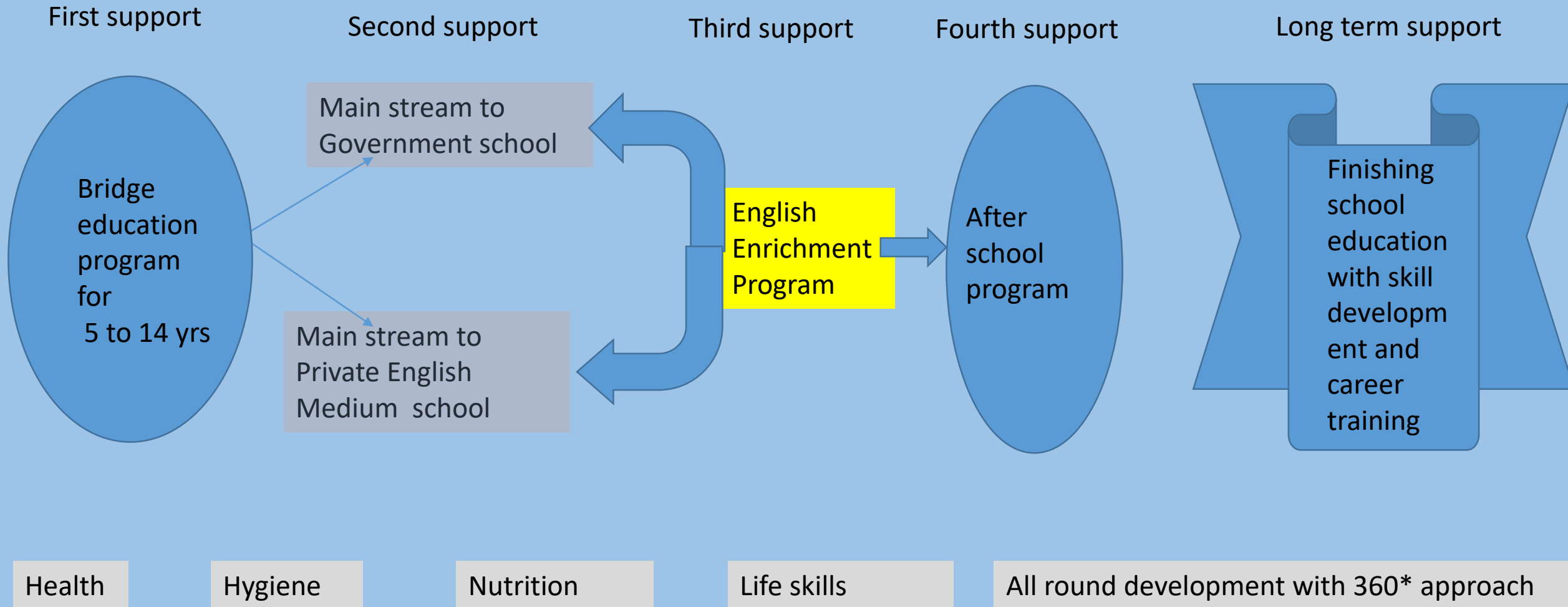

A year back.....

During bridge program, Sumana was 6 years old and initially her parents were not supportive and not sending her regularly to school. We had lots of challenges to bridge her gap in education as the child was irregular. But over a period of 6 months, her mother had understood our persistent efforts and seen her improvements gradually not only in academics but also in attitude. As a result the child became very regular to school and graduated at the end of our program in May 2018 and we mainstreamed her in class 1 of Brilliant Academy School on May, 2018.

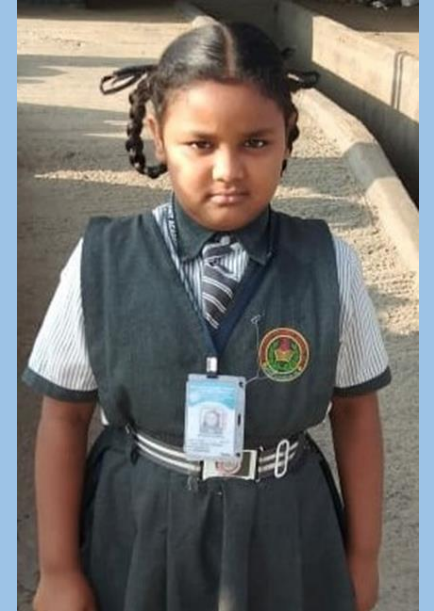


• Now.....
