 - ii) The Income & Expenditure account and Balance Sheet should be submitted annually to the I.T.O. having jurisdiction over the case.
 - iii) The amendments if any made to the Trust Deed or Memorandum of Association should be intimated to this office and the concerned ITO immediately whenever made.
 - iv) If any further renewal is required, application in prescribed Form No. 10G along with Income & Expenditure account and Balance Sheet, copy of Registration certificate u/s. 12-AA and copy of latest exemption certificate u/s. 80-G (each in triplicate) should be made to the concerned Commissioner of Income Tax.
